The cost of the trip will be \$18.00 for students and includes admission to the Natural History Center and charter bus transportation. Please make your check payable to VCS. The attached parental consent form must be filled out completely and signed for your child to participate. Payment and consent form are due no later than **Friday**, **February 23rd**. As with all field trips, no refunds will be given and no late payments will be accepted.

Each classroom is in need of two (2) parent chaperones to serve as helpers for this trip; one parent per family, please. Please indicate if you are interested in being a chaperone on the bottom portion of this page and return it to your child's teacher on or before Thursday, February 8th. A drawing will be held on Monday, February 12th and parents will then be notified. Consideration for the drawing will be given first to the families who did not have a parent attend the field trip to St. Augustine. To be eligible for the drawing as a chaperone, a completed volunteer application along with a copy of your driver's license must be submitted to VCS on, or before, February 8th.

All parent chaperones will need to provide their own transportation. The cost for parents will be \$12.00 for an admission fee. Parents chosen as chaperones will need to submit payment along with their child's according to the due date listed above. Parent chaperones will earn 4 hours of PI service time. Additional adults and siblings will not be allowed on the trip.

Parents who attend the field trip are welcome to sign out their child with the teacher at the end of the field trip so that he/she may ride home with them. Please be aware that PI time will end at the time your student is checked out. If you have any questions, please contact your child's teacher.
